1. **Tilagupha Municipality, Galje, Kalikot has allocated funds** from GoN towards the cost of Galje-Chilkhaya road upgrading works and intends to apply part of the funds to cover eligible payments under the Contract for Galje-Chilkhaya road upgrading works and identification number is TM/NCB/ROAD/W/03/2083/84. Bidding is open to all eligible as per Section V of bidding document.
2. Tilagupha Municipality, Galje, Kalikot invites sealed bids or electronic bids from eligible bidders for the construction of Galje-Chilkhaya road upgrading works under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 29800000.00**
 - Minimum Work experience of similar size and nature: At least one road construction contract with a value of at least NRs. 23150000.00
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Tilagupha Municipality, Galje, Kalikot or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. Bidders who choose to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp at no cost.
6. Pre-bid meeting shall be held at Tilagupha Municipality, Technical Section, Galje Kalikot at 1:00 Pm at 2083.05.05
7. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egpon or before **12:00 PM** on 2083/05/15. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:30 PM on **2083.05.15** at the office of Tilagupha Municipality, Galje, kalikot. Bids must be valid for a period of 90 days, from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of 1790000, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
